

Monarch Airlines, alternatively referred to as Monarch, was a British airline initially established as a charter and scheduled carrier by Bill Hodgson and Don Peacock. Financial support came from the Swiss Sergio Mantegazza family. In 2004, the company transitioned into a low-cost airline model and ceased all charter operations. Monarch Airlines was headquartered in Luton and operated from bases located at Birmingham, Leeds/Bradford, Gatwick, and Manchester.



Nouvelair Limited Company, also known as Nouvelair Tunisie or simply Nouvelair, is an airline based in Tunisia. The company's registered office is located in Tunis, while its head office is situated in the Dhkila Tourist Zone in Monastir, near the Hôtel Sahara Beach. Nouvelair specializes in operating tourist charters from various European cities to popular Tunisian holiday resorts. Its main bases include Monastir Habib Bourguiba International Airport, Tunis-Carthage International Airport, and Djerba-Zarzis International Airport.



Niger Airlines is a Nigerian carrier headquartered in Niamey. Established in 2012 as a replacement for the defunct Air Niger, the airline commenced operations in 2014. Its primary hub is situated at Diori Hamani International Airport. It is important to note that Niger Airlines should not be confused with Niger Airways, which also operates from Niamey.

Diori Hamani International Airport, located 9 kilometers southeast of Niamey, serves as the main airport for the capital city of Niger. It is positioned in the suburban area and is easily accessible via National Route 1, a major highway connecting Niamey with the eastern region of the country.



Senegal Airlines, established in 2009 to replace Air Sénégal International, was based in Dakar and operated from Léopold Sédar Senghor International Airport. Facing financial challenges, it ceased operations in 2016, paving the way for the creation of Air Senegal in 2018.
